Between July 31, 2019 and August 6, 2019, 2176423 Ontario acquired (the “**Acquisition**”) ownership of 926,500 Shares over the TSX Venture Exchange. 2176423 Ontario is beneficially owned by Eric Sprott. The Acquisition represents more than 2% of the outstanding Shares of the Corporation on a non-diluted basis.

The 926,500 Shares represent approximately 2.2% of the outstanding Shares on a non-diluted basis.

Prior to the Acquisition, Mr. Sprott beneficially owned 2,500,000 Shares and 2,500,000 Share purchase warrants, representing approximately 5.8% of the current outstanding Shares on a non-diluted basis and approximately 11.0% on a partially diluted basis assuming exercise of such warrants.

After giving effect to the Acquisition, Mr. Sprott beneficially owns and controls 3,426,500 Shares and 2,500,000 warrants representing approximately 8.0% of the issued and outstanding Shares on a non-diluted basis, and approximately 13.1% on a partially diluted basis assuming exercise of all warrants.

Mr. Sprott has a long-term view of the investment and may acquire additional securities including on the open market or through private acquisitions or sell the securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
