**NOTICE OF ANNUAL MEETING OF SHAREHOLDERS**

**NOTICE IS HEREBY GIVEN** that the annual meeting of shareholders (the “**Meeting**”) of Arch Biopartners Inc. (the “**Corporation**”) will be held at the Corporation’s head office located at 545 King Street West, Toronto, Ontario, Canada on April 3, 2018 at 11:00 a.m. (Toronto time) for the following purposes:

1. To receive the consolidated audited financial statements of the Corporation for the fiscal year ended September 30, 2017 and the respective auditors’ report thereon;
2. To elect directors of the Corporation for the ensuing year;
3. The re-appointment of Exchange Group Chartered Professional Accountants LLP as auditors of the corporation and to authorize the directors to fix the auditor’s remuneration;
4. To consider, and if thought fit, pass, with or without variation, an ordinary resolution providing for the annual approval of the Corporation’s current stock option plan;
5. To transact such other business as may properly be brought before the Meeting or any adjournment thereof.
