The transaction giving rise to this report was the closing of an asset acquisition, pursuant to which the Common Shares were issued as payment of part of the purchase price, on December 29, 2020.

Incorporation: NAWOC was incorporated under the *Business Corporations Act* (Ontario)

Principal Business: NAWOC is a private company, that owns industrial properties in Ontario.

On December 29, 2020, the Acquiror acquired ownership and control of 20,000,000 Common Shares of Parkit at a deemed price of \$0.25 per Common Share, representing 17.4% of the issued and outstanding Common Shares of the Issuer. The Common Shares were issued to the Acquiror, as vendor, by the Issuer, as purchaser, as payment of part of the purchase price pursuant to the closing of an asset acquisition.

See item 2.2. The Acquiror acquired ownership and control of 20,000,000 Common Shares of Parkit at a deemed price of \$0.25 per Common Share, representing 17.4% of the issued and outstanding Common Shares of the Issuer.

NAWOC acquired ownership of and control over the 20,000,000 Common Shares.

Prior to the acquisition of the 20,000,000 Common Shares, NAWOC did not own or control any securities of the Issuer. NAWOC now owns and controls 20,000,000 Common Shares, representing 17.4% of the issued and outstanding Common Shares of the Issuer.

The Acquiror now owns and controls 20,000,000 Common Shares of the Issuer (17.4%).

See item 2.2. The Acquiror acquired ownership and control of 20,000,000 Common Shares of Parkit at a deemed price of \$0.25 per Common Share, having an aggregate value of \$5,000,000.

The Common Shares were issued to the Acquiror, as vendor, by the Issuer, as purchaser, as payment of part of the purchase price pursuant to the closing of an asset acquisition. Presently, the Acquiror has no intention of acquiring any further securities of the Issuer. The Acquiror may acquire ownership of or control over further securities of the Issuer in the future depending upon market circumstances. Increase or decrease in ownership of securities of the Issuer will depend on numerous conditions, including the price of the Common Shares and general market conditions.

The 20,000,000 Common Shares were issued to the Acquiror as payment of part of the purchase price for the closing pursuant to the terms of an asset purchase agreement on December 29, 2020, between NAWOC and SRS Realty Group Inc., as vendors, and the Issuer, as purchaser, pursuant to which the Issuer agreed to purchase two industrial properties, for an aggregate purchase price of \$36,250,000, subject to customary adjustments
