The Issuer’s issued and outstanding share capital increased in November 2024. As a result of the foregoing, the partially diluted holdings in the Issuer of Crescat have fallen below 15%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

There has been a net increase of 663,379 common shares of the Issuer (“**Common Shares**”) and an increase of 156,250 share purchase warrants of the Issuer (“**Warrants**”) in Crescat’s holdings; however, due to an increase in the Issuer’s issued and outstanding share capital, there has been a decrease of approximately 1.15% in Crescat’s securityholding percentage on a partially diluted basis.

As at November 30, 2024, Crescat exercised control over 4,588,379 Common Shares, representing approximately 9.17% of the outstanding Common Shares and 3,406,250 share purchase warrants of the Issuer (“**Warrants**”). Assuming that all of the Warrants held by Crescat are exercised, Crescat will hold 7,994,629 Common Shares representing approximately 14.96% of the outstanding Common Shares on a partially diluted basis as at November 30, 2024.
