On October 24, 2025, 2176423 Ontario acquired (the “**Acquisition**”) 3,333,333 Units of the Corporation at a price of \$0.30 per Unit. Each Warrant entitles the holder thereof to acquire one Share at a price of \$0.45 per Share until 18 months after the issuance of the Warrant, The Units were purchased from the Corporation on a private placement basis. 2176423 Ontario is beneficially owned by Eric Sprott.

The Acquisition of 3,333,333 Units resulted in holdings of approximately 8.8% of the outstanding Shares on a non-diluted basis and approximately 11.4% on a partially diluted basis, representing an increase in holdings to above 10 % of the outstanding Shares. See items 2.2 and 3.4.

Mr. Sprott acquired beneficial ownership of the Units. See item 2.2.

Prior to the Acquisition, Mr. Sprott owned 14,393,939 Shares and 4,166,666 Warrants, representing approximately 7.7% of the outstanding Shares on a on a non-diluted basis and 9.7% of the outstanding Shares on a partially-diluted basis assuming exercise of such Warrants.

Mr. Sprott now beneficially owns 17,727,272 Shares and 5,833,332 Warrants, representing approximately 8.8% of the outstanding Shares on a non-diluted basis and 11.4% of the outstanding Shares on a partially-diluted basis assuming exercise of such Warrants.

Mr. Sprott currently has no other plans or intentions that relate to, or would result in, the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
