AMENDING AGREEMENT NO. 39 made as of **March 29, 2023**

BETWEEN:

Purpose Investments Inc. on behalf of the fund(s) listed in Schedule “A” (collectively, the “**Fund(s)**”), in its capacity as manager of the Fund(s) and not in its personal capacity (the “**Manager**”)

- and -

CIBC Mellon Trust Company, a trust company existing under the laws of Canada (the “**Custodian**”)

WHEREAS:

- a) the parties hereto entered into a Custodial Services Agreement dated August 1, 2013, as amended (the “**Custody Agreement**”);
- b) the parties hereto agree that this amending agreement is the thirty-ninth (39th) amendment to the Custody Agreement;
- c) the parties hereto agree that amending agreement number thirty-five (35) to the Custody Agreement has not been or will be executed;
- d) amending agreement number thirty-one (31) to the Custody Agreement dated **March 30, 2023** added Stonecastle Global Tactical Asset Allocation to the list of Funds in Schedule A and has not launched to date and thus shall be removed from the list of Funds in Schedule A; and
- e) Section 10.1 of the Custody Agreement provides that it may not be amended except by written agreement signed by the parties; and the parties enter into this amending agreement to remedy the foregoing and make the following changes to the list of Funds in Schedule “A” of the Custody Agreement:

Terminate the following Funds, effective March 29, 2023:

- Purpose US Dividend Fund
- Purpose Behavioral Opportunities Fund
- Purpose Crypto Opportunities ETF

Name change of the following Fund, effective September 14, 2022:

- Purpose Cash Management Portfolio to Purpose Cash Management Fund

NOW THEREFORE, in consideration of the mutual covenants and agreements contained herein and other good and valuable consideration, the receipt and sufficiency of which is hereby

acknowledged by the parties hereto, the parties each intending to be legally bound, agree as follows:

1. Effective as of March 29, 2023, the Custody Agreement is hereby amended by deleting Schedule "A" thereto and replacing it with Schedule "A" attached hereto.
2. All capitalized terms not otherwise defined in this amending agreement have the meaning given thereto in the Custody Agreement.
3. This amending agreement shall be construed in accordance with and governed by the laws of the Province of Ontario and the federal laws of Canada applicable thereto.
4. Except as specifically provided by this amending agreement, all terms and conditions of the Custody Agreement are hereby ratified and confirmed.
