On May 21, 2019, the Company and the Acquiror, entered into a subscription agreement (the “**Agreement**”) pursuant to which the Acquiror subscribed, on behalf of Zijin Global Fund, a fund managed by the Acquiror, for 250,000 convertible debentures (the “**Debentures**”) from the Company at a price of \$1.00 per Debenture for an aggregate of \$250,000 (the “**Indebtedness**”). The Debentures were convertible, at the option of the Acquiror, into common shares (the “**Shares**”) at a conversion price of one Share for every \$0.10 of Indebtedness. The Acquiror could exercise its rights of conversion until the close of business on May 21, 2021. The Acquiror has exercised its conversion rights with respect to \$240,000 of the Indebtedness to acquire 2,400,000 Shares.

Prior to the conversion of the Debentures, the Acquiror held 2,725,000 Shares and the Acquiror’s non-diluted shareholdings represented approximately 11.93% of the Company’s issued and outstanding Shares.

As a result of issuance of the Shares pursuant to conversion of the Debentures, the Acquiror now holds 5,125,000 Shares, and the Acquiror’s non-diluted shareholdings represent approximately 19.9% of the

Company's issued and outstanding Shares.
