On December 9, 2024, Wave Force acquired 667,000 units of the Company (the “Unit”) at a price of \$0.15 per Unit. Each Unit is comprised of one common share of the Company (a “Share”) and one common share purchase warrant (a “Warrant”). Each Warrant entitle the holder to acquire one additional Share at a price of \$0.25 per Share. Warrants have expiry date as July 31, 2026.

common shares which is equal to approximately 36.50% of the issued and outstanding common shares.
