2176423 Ontario (a corporation beneficially owned by Eric Sprott) acquired 4,370,333 Shares of Luxor Metals. pursuant to the closing of a spin-out transaction effected through a statutory plan of arrangement (“Arrangement”) between Teuton Resources Corp. (“Teuton Resources”) and the Corporation completed on May 16, 2025.

As a result of the Arrangement, the holders common shares of Teuton Resources. received one Share of the Corporation for every three common shares of Teuton Resources they held on the record date for the Arrangement. Mr. Sprott beneficially owned 13,111,000 common shares of Teuton Resources on the record date.

Mr. Spratt has a long-term view of the investment and may acquire additional securities of the Corporation including on the open market or through private acquisitions or sell the securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Spratt currently has no other plans or intentions that relate to, or would result in, the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Spratt may develop such plans or intentions in the future.
