As a result of net sales of common shares of the Issuer (“**Common Shares**”) by Crescat, and an increase in the Issuer’s issued and outstanding share capital, in August 2025, the partially diluted holdings in the Issuer of Crescat have fallen below 12.5%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, Kevin and Linda Smith Living Trust dtd 7/21/1998, and Kevin and Linda Smith Charitable Trust UAD 08/07/2023 (the “**Joint Actors**”) may be considered joint actors.

There has been a net decrease of 3,086,709 Common Shares in Crescat's holdings; as a result of the foregoing and due to an increase in the Issuer's issued and outstanding share capital, there has been a decrease of approximately 2.57% in Crescat's securityholding percentage.

As at August 31, 2025, Crescat exercised control over 16,092,447 Common Shares, representing approximately 10.22% of the outstanding Common Shares, and 2,420,000 Common Share purchase warrants of the Issuer ("Warrants"). Assuming that all of the Warrants held by Crescat are exercised, Crescat will hold 18,512,447 Common Shares representing approximately 11.58% of the issued Common Shares on a partially diluted basis as at August 31, 2025.
