As a result of net sales of common shares of the Issuer (“**Common Shares**”) by Crescat in December 2025, Crescat’s partially diluted holdings in the Issuer have fallen below 10%.

There has been a net decrease of 15,717,113 Common Shares and 920,000 Common Share purchase warrants (“**Warrants**”) in Crescat’s holdings. As a result of the foregoing there has been a decrease of approximately 9.99% in Crescat’s securityholding percentage on a non-diluted basis and, assuming that all of the Warrants held by Crescat are exercised, a decrease in Crescat’s securityholding percentage of approximately 10.44% on a partially diluted basis.

As at December 31, 2025, Crescat exercised control over 375,334 Common Shares, representing approximately 0.23% of the issued and outstanding Common Shares, and 1,500,000 Warrants. Assuming that all of the Warrants held by Crescat are exercised, Crescat will hold 1,875,334 Common Shares, representing approximately 1.14% of the issued and outstanding Common Shares on a partially diluted basis as at December 31, 2025.
