Management Discussion and Analysis
For the Period ended September 30, 2019

The following management discussion and analysis (“MD&A”) of the results of the operations and financial position of Skyscape Capital Inc. (the “Corporation” or “Skyscape”) for the three and nine months ended September 30, 2019 should be read in conjunction with the Corporation’s unaudited condensed interim financial statements for the three and nine month periods ended September 30, 2019, for the three month period ended September 30, 2018 and for the period from incorporation (January 9, 2018) to September 30, 2018. All figures contained in this MD&A are presented in Canadian dollars.

Forward-Looking Statements

Certain statements contained in this MD&A may constitute forward-looking statements. These statements relate to future events or the Corporation’s future performance. All statements, other than statements of historical fact, may be forward-looking statements.

The Corporation believes that the expectations reflected in those forward-looking statements are reasonable, but no assurance can be given that these expectations will prove to be correct and such forward-looking statements included in this MD&A should not be unduly relied upon by investors as actual results may vary. These statements speak only as of the date of this MD&A and are expressly qualified, in their entirety, by this cautionary statement. The Corporation’s actual results could differ materially from those anticipated in these forward-looking statements as a result of various risk factors.

The Corporation

Skyscape Capital Inc. (the "Corporation") was incorporated under the Business Corporations Act (Ontario) on January 9, 2018 and is a Capital Pool Corporation as defined in Policy 2.4 of the TSX Venture Exchange (the “Exchange”) Corporate Finance Manual. The head office and the registered head office of the Company is located at 77 King Street West, Suite 700, Toronto, ON M5K 1G8.

The principal business of the Corporation is the identification and evaluation of assets or businesses with a view to completing a Qualifying Transaction (“QT”) as such term is contemplated in the Manual. The Corporation has not commenced operations and has no

assets other than cash held in trust. The Corporation's continuing operations as intended are dependent upon its ability to identify, evaluate and negotiate an acquisition, or business, or an interest therein. Such an acquisition will be subject to the approval of the regulatory authorities concerned and, in the case of a non-arm's length transaction, of the majority of the minority shareholders.

The proceeds raised from the issuance of share capital may only be used to identify and evaluate assets or businesses for future investment, with the exception that up to the lesser of 30% of the gross proceeds realized by the Corporation in respect of the sale of its securities or \$210,000, may be used for purposes other than evaluating businesses or assets. These restrictions apply until completion of a QT by the Corporation. The Corporation is required to complete its QT on or before two years from the date the Corporation's shares were first listed on the Exchange.

During the period from incorporation (January 9, 2018) to December 31, 2018, the Corporation issued 1,000,000 common shares at \$0.25 per share for gross proceeds of \$250,000.

On March 6, 2018, the Corporation completed its Initial Public Offering ("IPO") of 1,000,000 common shares at \$0.50 per share (\$500,000). The Corporation paid a commission of 10% of the gross proceeds to Canaccord Genuity Corp. (the "Agent"), and granted the Agent warrants to acquire 10% of the common shares issued in the IPO exercisable for a period ending twenty-four months from the closing of the IPO, exercisable at \$0.50 per share. The Corporation also paid a corporate finance fee and reimbursed the Agent for legal fees and other reasonable expenses incurred pursuant to the Offering. Cash issuance costs of \$72,202 were associated with these issuances and the value attributed to warrants granted to the Agent is \$26,444.

Concurrently with the completion of the IPO, the Corporation granted 200,000 stock options to its directors and officers at an exercise price of \$0.50 per share for a period of five years from the grant date.

On November 25, 2019 the Board of Directors approved the unaudited condensed interim financial statements for the three and nine month periods ended September 30, 2019, for the three month period ended September 30, 2018 and for the period from incorporation (January 9, 2018) to September 30, 2018.

Results of Operations

Three month period ended September 30, 2019

The Corporation recorded a net loss of \$324,141 during the three month period ended September 30, 2019 (2018 - \$40,331). The net loss for the three month period ended September 30, 2019 is due mainly due to costs in relation to its listing on the Exchange and professional fees.

Nine month period ended September 30, 2019

The Corporation recorded a net loss of \$195,480 during the nine month period ended September 30, 2019 (2018 - \$231,042). The net loss for the nine month period ended September 30, 2019 is due mainly due to costs in relation to its listing on the Exchange and professional fees.

Since the Corporation has no revenue from operations, the following is a breakdown of the material costs incurred from the date of incorporation (January 9, 2018) to September 30, 2019:

Liquidity and Capital Resources

As at September 30, 2019, the Corporation had cash of \$324,141. The Corporation had current liabilities of \$11,110 and working capital of \$313,031.

Negative cash flows of \$194,500 (2018 - \$141,661) were recorded from operating activities during the nine month period ended September 30, 2019. This is primarily due to outflows relating to filing fees and professional fees.

Outstanding Share Data

As of the date of this MD&A, 2,000,000 common shares are issued and outstanding. In addition, there are 200,000 stock options outstanding, exercisable at \$0.50 per share, expiring on March 6, 2023 and 100,000 Agent's Warrants outstanding, exercisable at \$0.50 per share, expiring on March 6, 2020.

Off-Balance Sheet Arrangements

The Corporation has not had any off-balance sheet arrangements from the date of its incorporation to the date of this MD&A.

Related Party Transactions

During the nine month period ended September 30, 2019, the Corporation incurred legal fees of approximately \$172,314 (2018 - \$95,258) for services provided by a law firm whose partner is a director of the Corporation. As at September 30, 2019, \$11,110 (2018 - \$12,683) is included in accrued liabilities for these services.

There were no other transactions with related parties and no remuneration was paid to key management personnel during the three and nine month periods ended September 30, 2019, during the three month period ended September 30, 2018 and during the period from incorporation (January 9, 2018) to September 30, 2018.

Capital Management

The Corporation's objective when managing capital is to maintain its ability to continue as a going concern in order to provide returns for shareholders and benefits for other stakeholders.

The Corporation includes equity, comprised of share capital and accumulated deficit, in the definition of capital.

The Corporation's primary objective with respect to its capital management is to ensure that it has sufficient cash resources to fund the identification and evaluation of potential acquisitions. To secure the additional capital necessary to pursue these plans, the Corporation may attempt to raise additional funds through the issuance of equity or by securing strategic partners.

The proceeds raised from the issuance of common shares may only be used to identify and evaluate assets or businesses for future investment, with the exception that not more than the lesser of 30% of the gross proceeds from the issuance of shares or \$210,000 may be used to cover prescribed costs of issuing the common shares or administrative and general expenses of the Corporation. These restrictions apply until completion of a QT by the Corporation.

Risks and Uncertainties

The following describes certain risks, events and uncertainties that could affect the Corporation and that each reader should carefully consider. Please refer to the Corporation's final prospectus dated February 20, 2018 for additional risks, events and uncertainties that could affect the Corporation.

External financing may be required to fund the Corporation's activities primarily through the issuance of common shares. There can be no assurance that the Corporation will be able to obtain adequate financing. The securities of the Corporation should be considered a highly speculative investment.

The Corporation has not generated significant revenues and does not expect to generate significant revenues in the near future. In the event that the Corporation generates significant revenues in the future, the Corporation intends to retain its earnings in order to finance further growth. Furthermore, the Corporation has not paid any dividends in the past and does not expect to pay any dividends in the foreseeable future.

Risk Disclosures and Fair Values

The Corporation's financial instruments, consisting of cash held in trust and accrued liabilities approximate fair value due to the relatively short-term maturity of the instruments. It is management's opinion that the Corporation is not exposed to significant interest, currency or credit risks arising from these financial instruments.

Critical Accounting Estimates

The Corporation's significant accounting policies are summarized in Note 2 to the audited financial statements for the period from incorporation (January 9, 2018) to December 31, 2018.
