On November 25, 2020, Mr. Oswald subscribed for 500,000 units (the “Units”), each Unit consisting of one (1) common share and (1) one half of a share purchase warrant exercisable at \$0.30 per share until May 25, 2022, under a private placement in the capital of the Issuer (the “Transaction”).

Prior to Mr. Oswald's participation in the Transaction, he owned or had direction over 2,063,000 common shares, 1,400,000 warrants, totalling approximately 5.95% of the then issued and outstanding shares of the Issuer. Subsequent to the Transaction, he now owns or has direction over 2,563,000 common shares, 1,650,000 warrants, totalling approximately 7.17% of the issued and outstanding shares of the Issuer.

Mr. Oswald acquired a further 500,000 Units (one common share and one share purchase warrant) in the Issuer's private placement.

Mr. Oswald, directly or indirectly, acquired pursuant to the Transaction the 500,000 Units of the Issuer at a purchase price of \$0.21 per Unit for total consideration of \$105,000.
