On December June 22, 2018, Palisade disposed of 1,300,000 shares (“**Grid Shares**”) of Grid Metals Corp. Palisade now holds 2,549,914 Grid Shares and 1,842,857 Grid Warrants. Palisade’s 2,549,914 Grid Shares represent approximately 6.0% of Grid’s issued and outstanding common shares. The 2,549,914 Grid Shares and 1,842,857 Grid Warrants held by Palisade

collectively represent approximately 9.99% of the issued and outstanding common shares of Grid, assuming the exercise of the Grid Warrants. Palisade is no longer and insider of Grid Metals Corp.
