On November 2, 2021, Shapoorji Pallonji International FZC acquired 213,333 common shares of the Company at a price of \$0.15 per Share pursuant to the exercise of previously issued stock options. These securities, representing approximately 0.35% of the issued and outstanding common shares of the Company.

The Acquiror disposed of 213,333 stock options and acquired 213,333 Common Shares upon exercise of stock options that triggered the requirement to file this report.

Following the acquisition of the shares, the Acquiror holds an aggregate of 26,013,333 Common Shares of the Issuer, representing 43.27% of the Company's issued and outstanding shares.
