On November 29, 2019, 2176423 Ontario acquired (the “**Acquisition**”) ownership of 28,000,000 Units of the Corporation at a price of \$0.50 per Unit. Each Warrant comprising part of a Unit entitles the holder thereof to acquire one Share at a price of \$0.65 per Share until November 26, 2021 (subject to accelerated expiry). The Units were purchased from the Corporation on a private placement basis. 2176423 Ontario is beneficially owned by Eric Sprott.

The 28,000,000 Units represent approximately 8.5% of the issued and outstanding Shares on a non-diluted basis, and approximately 12.3.% on a partially diluted basis. See item 3.4

Mr. Sprott acquired beneficial ownership of the Shares. See item 2.2.

Prior to the date hereof, Mr. Sprott beneficially owned and controlled 1,893,500 Shares representing approximately 0.6% of the then issued and outstanding Shares .

After giving effect to the Acquisition, Mr. Sprott beneficially owns and controls 29,893,500 Shares and 14,000,000 Warrants representing approximately 9.1% of the issued and outstanding Shares on a non-diluted basis, and approximately 12.8% on a partially diluted basis assuming exercise of the Warrants.

The Units were acquired for investment purposes. Mr. Sprott has a long-term view of the investment and may acquire additional securities of the Corporation including on the open market or through private acquisitions or sell the securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.

Item 6 – Agreements, Arrangements, Commitments or Understandings With Respect to Securities of the Reporting Issuer
