On August 1, 2019, pursuant to a definitive share purchase agreement (“**SPA**”) originally dated May 24, 2019 between the Issuer and NETC, the Issuer acquired all of the issued and outstanding shares of NETC’s three subsidiary companies in consideration for issuing 37,500,000 Common Shares of the Issuer to NETC at a deemed price of \$0.08 per Common Share (the “**Transaction**”).

After giving effect to the acquisition, NETC has direct or indirect ownership of or control over 37,500,000 common shares of the Issuer, representing approximately 26.22% of the issued and outstanding common shares of the Issuer (on an undiluted basis).

Pursuant to the terms of the SPA, NETC received approximately \$3,000,000 in common shares of the Issuer for consideration of the shareholdings of NETC's subsidiaries, being approximately \$0.08 per Common Share of the Issuer.
