As a result of net sales of common shares of the Issuer (“**Common Shares**”) by Crescat and the Joint Actors (as defined below) in June 2021, the collective holdings of Crescat and the Joint Actors in the Issuer have fallen below 10%.

Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

The aggregate number of Common Shares held and the number of Common Shares that may be acquired by Crescat pursuant to the exercise of common share purchase warrants of the Issuer (“**Warrants**”) has decreased by 6,235,800 Common Shares representing a decrease of approximately 3.15%.

As at June 30, 2021, Crescat exercised control over 16,283,297 Common Shares, representing approximately 5.82% of the outstanding Common Shares, and Warrants to purchase 8,115,383 Common Shares. Assuming that the Warrants are exercised, Crescat will hold 24,398,680 Common Shares representing approximately 8.47% of the issued Common Shares on a partially diluted basis as at June 30, 2021.

As at June 30, 2021, Crescat and the Joint Actors collectively exercised control over a total of 16,283,297 Common Shares (representing approximately 5.82% of the outstanding Common Shares) and 8,177,883 Warrants. Assuming the Warrants are exercised, Crescat and the Joint Actors will collectively exercise control over an aggregate of 24,461,180 Common Shares representing approximately 8.49% of the outstanding Common Shares on a partially diluted basis as at June 30, 2021.
