NOTICE OF ANNUAL GENERAL AND SPECIAL MEETING OF SHAREHOLDERS

NOTICE IS HEREBY GIVEN that an annual general and special meeting (the “**Meeting**”) of the holders of common shares (the “**Shareholders**”) of Murchison Minerals Ltd. (the “**Corporation**”) will be held at the Ontario Bar Association Conference Centre, Suite 200, 20 Toronto Street, Toronto, Ontario at 1:00 p.m. (Toronto time) on Wednesday, May 1, 2024, for the following purposes:

1. To receive and consider the audited financial statements of the Corporation for the financial year ended December 31, 2023 and the auditor’s report thereon;
2. To set the board of directors at seven (7) and to elect the directors of the Corporation for the ensuing year;
3. To appoint McGovern Hurley LLP, Chartered Professional Accountants, as the auditor of the Corporation for the ensuing year and to authorize the directors to fix its remuneration;
4. To approve the Corporation’s new Stock Option Plan; and
5. To transact such other business as may properly come before the Meeting or any adjournments or postponements thereof.

Shareholders who are unable to attend the Meeting in person, are requested to date, complete, sign and return the enclosed form of proxy so that as large a representation as possible may be had at the Meeting.
