Crescat, an investment manager with discretionary authority operating in the United States, acquired 3,784,000 previously issued common shares of the Issuer (“**Common Shares**”) and 3,784,000 previously issued share purchase warrants of the Issuer (“**Warrants**”) through a private transaction that closed on March 5, 2021.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

Crescat is eligible to file reports under Part 4 in respect of the Issuer.

As at March 31, 2021, Crescat exercised control over 4,066,108 Common Shares, representing approximately 10.60% of the outstanding Common Shares, and Warrants to purchase 3,784,000 Common Shares. Assuming that the Warrants are exercised, Crescat will hold 7,850,108 Common Shares representing approximately 18.63% of the issued Common Shares on a partially-diluted basis.

Crescat and the Joint Actors collectively exercise control over a total of 4,091,108 Common Shares (representing approximately 10.67% of the

outstanding Common Shares) and 3,784,000 Warrants. Assuming the Warrants are exercised, Crescat and the Joint Actors will collectively exercise control over an aggregate of 7,875,108 Common Shares representing approximately 18.69% of the outstanding Common Shares on a partially-diluted basis.
