The requirement to file this report was triggered as of November 30, 2019 as a result of the decrease in the Eligible Institutional Investor’s holdings of Common Shares of the Issuer to below 10% (as well as 12.5% and 15%) for Adrian Day Asset Management of the total Common Shares of the Issuer. See Item 3.1.

Adrian Day is eligible to file reports under Part 4 of National Instrument 62-103 in respect of the Issuer.

Since the last report dated July 3, 2019, Adrian Day, on behalf of its asset management clients, acquired an aggregate of 68,500 Shares. Additionally, the Shares held on behalf of asset management clients were decreased by 9,792,000 Shares pursuant to sales in the public market in the amount of 269,000 Shares, 45,000 Shares due to the closure of accounts, and 9,478,000 Shares were removed from management counts due to the change in structure of the firm. These latter holdings, held by the EuroPac Gold Fund, will be filed separately by Euro Pacific Asset Management, the advisor to the Fund. These transactions resulted in an increase in holdings of Adrian Day, on behalf of its asset management clients, from approximately 17.2% to 6.4% of the issued and outstanding Shares.

Adrian Day Asset Management previously discussed a joint actor in Item 2.3 and Item 5: EuroPac Gold Fund, an investment fund for which Adrian Day Asset Management served as sub-advisor. That statement has been removed in order to reflect a change in the structure of the firm. While Adrian Day still manages this Fund, due to this change in structure, Adrian Day Asset Management will no longer be reporting holdings for the Fund as they instead will be reported by Euro Pacific Asset Management, the advisor to the EuroPac Gold Fund.

Item 7 Certification
