2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.

The requirement to file this report was triggered by the closing of the Private Placement on May 9, 2025, in which Crescat acquired 2,333,334 units of the Issuer (the “**Units**”) at a price of \$0.12 per Unit. Each Unit was comprised of one common share of the Issuer (each, a “**Common Share**”) and one common share purchase warrant of the Issuer (each, a “**Warrant**”). Each Warrant entitles the holder thereof to acquire one Common Share at a price of \$0.15 per Common Share for a term of two years and a price of \$0.20 for an additional 12 months thereafter.

As a result of the Private Placement, the collective partially diluted holdings in the Issuer of Crescat and the Joint Actors (as defined herein) have risen above 20%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, Kevin and Linda Smith Living Trust dtd 7/21/1998, and Kevin and Linda Smith Charitable Trust UAD 08/07/2023 (the “**Joint Actors**”) may be considered joint actors.

Crescat is eligible to file reports under Part 4 in respect of the Issuer.

There has been a net increase of 15,959,336 Common Shares and a net decrease of 11,433,333 Warrants in Crescat’s holdings, representing a net increase in Crescat’s securityholder percentage of approximately 8.71% on a non-diluted basis and, assuming that all of the Warrants held by Crescat are exercised, a net increase in Crescat’s securityholder percentage of approximately 0.99% on a partially diluted basis.

As at June 30, 2025, Crescat exercised control over 28,809,336 Common Shares, representing approximately 19.22% of the outstanding Common Shares, and 1,166,667 Warrants. Assuming that all of the Warrants held by Crescat are exercised, Crescat will hold 29,976,003 Common Shares representing approximately 19.84% of the outstanding Common Shares on a partially diluted basis as at June 30, 2025.

As at June 30, 2025, Crescat and the Joint Actors collectively exercised ownership and control over a total of 29,709,336 Common Shares, representing approximately 19.82% of the outstanding Common Shares, and 1,166,667 Warrants. Assuming that all of the Warrants held by Crescat and the Joint Actors are exercised, Crescat and the Joint Actors will collectively exercise ownership and control over an aggregate of 30,876,603 Common Shares representing approximately 20.44% of the outstanding Common Shares on a partially diluted basis as at June 30, 2025.
