Agnico Eagle is a senior gold mining company organized under the laws of the Province of Ontario.

On September 26, 2025, Agnico Eagle sold 47,944,981 Ordinary Shares in a sale through the facilities of the TSX Venture Exchange at a price of \$0.115 per Ordinary Share (the "Disposition") for total consideration of \$5,513,673, for settlement on September 29, 2025.
