

Early Warning Reporting for Restaurant Brands International Limited Partnership and Restaurant Brands International Inc.

August 6, 2021

New York, NY – Pursuant to the terms of the Amended and Restated Limited Partnership Agreement of Restaurant Brands International Limited Partnership (“RBI LP”), HL1 17 LP (the “selling shareholder”), an affiliate of 3G Restaurant Brands Holdings LP (“3G RBH”), delivered to RBI LP an exchange notice to exchange in aggregate 9,608,744 exchangeable units of RBI LP (“Exchangeable Units”). As announced by RBI on August 4, 2021, Restaurant Brands International Inc. (“RBI”), in its capacity as general partner of RBI LP, elected to have RBI LP satisfy the exchange notice by issuing 9,608,744 common shares of RBI (“Common Shares”).

The selling shareholder has commenced an underwritten registered public offering of 9,608,744 Common Shares in the United States. The selling shareholder has entered into a forward sale contract with Morgan Stanley & Co. LLC (the “forward counterparty”) with respect to 9,608,744 Common Shares. In connection with the forward sale contract, the forward counterparty or its affiliates are expected to borrow and sell to the underwriter an aggregate of 9,608,744 Common Shares that will be delivered in connection with the underwritten registered public offering. The selling shareholder is expected to physically settle the forward sale contract by delivering to the forward counterparty the Common Shares received upon exchange of the Exchangeable Units. Upon settlement of the forward sale contract, the selling shareholder will receive a cash payment based on a price per share of US\$63.72 multiplied by a factor of (1+ (an overnight bank funding rate minus 50 basis points)) on each date the forward sale contract is outstanding. The settlement of the forward sale contract and the exchange are expected to occur on or before August 24, 2021.

After the exchange and the settlement of the forward sale contract, 3G RBH will continue to own 132,662,485 Exchangeable Units (representing approximately 91.31% of the outstanding Exchangeable Units) or, on an exchanged basis, 132,662,485 Common Shares (which would represent approximately 29.46% of the outstanding Common Shares (28.65% assuming the exchange of all Exchangeable Units)). Immediately prior to these events, 3G RBH owned 142,271,229 Exchangeable Units (which represented approximately 91.85% of the outstanding Exchangeable Units) or, on an exchanged basis, 142,271,229 Common Shares (which would have represented approximately 31.59% of the outstanding Common Shares (30.73% assuming the exchange of all Exchangeable Units)).

From time to time, 3G Restaurant Brands Holdings General Partner Ltd. (“3G RBH GP”), the general partner of 3G RBH and the selling shareholder, 3G RBH or their respective affiliates may exchange Exchangeable Units into Common Shares and/or acquire or dispose of securities of RBI or RBI LP depending upon a number of factors, including but not limited to general market and economic conditions and other available investment opportunities.
