("CI"). The Securities Lending Agent is independent of the Investment Manager and CI. The Securities

Lending Agreement requires each applicable borrower to deliver collateral having a market value equal to no less than 102% of the market value of the loaned securities. The Securities Lending Agreement requires RBC to indemnify the applicable fund(s) for certain losses incurred in connection with their failure to perform their obligations. The Investment Manager has the right to recall the securities or identical securities that have been transferred or lent under the arrangement.

As of November 30, 2020, 73,100 Shares were out on loan under the above-noted agreement.
