On August 12, 2022, the Issuer completed an acquisition of Gold Standard Ventures Corp. (“**Gold Standard**”) by way of a court-approved plan of arrangement (the “**Transaction**”). Under the terms of the Transaction, former Gold Standard shareholders received, in exchange for each Gold Standard common share, 0.1193 of a Common Share of the Issuer and C\$0.0001.

The Common Shares are indirectly held through Goldcorp Inc. (“**Goldcorp**”), Newmont’s wholly owned subsidiary. Newmont and Goldcorp may be considered joint actors with respect to the Issuer.

Immediately prior to the closing of the Transaction, Newmont, through Goldcorp, held 41,138,141 Common Shares, representing approximately 16% of the issued and outstanding Common Shares. Following completion of the Transaction, Newmont, through Goldcorp, holds 43,245,294 Common Shares, representing approximately 14.3% of the issued and outstanding Common Shares.
