This early warning report is being filed for information purposes, further to the press release of the Corporation dated August 11, 2020.

On August 7, 2020, 2176423 Ontario acquired (the "**Acquisition**") ownership of 11,111,000 Units of the Corporation, on a private placement basis, at a price of \$1.35 per Unit for total consideration of \$14,999,850. Each Warrant comprising part of a Unit entitles the holder thereof to acquire one Share at a price of \$.1.75 per Share for a two year period.

Prior to the Acquisition, Mr. Sprott beneficially owned 66,025,611 Shares and 9,090,909 Warrants representing approximately 24.8% of the outstanding Shares on a non-diluted basis and approximately 25.8% of the outstanding Shares on a partially diluted basis assuming exercise of the Warrants,

After giving effect to the Acquisition, Mr. Sprott beneficially owns and controls 77,136,611 Shares and 14,646,409 Warrants representing approximately 26.4% of the outstanding Shares on a non-diluted basis and approximately 29.9% of the outstanding Shares on a partially diluted basis assuming exercise of the Warrants.

Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
