On June 20, 2025, 2176423 Ontario, a corporation beneficially owned by Eric Sprott, sold 19,200,200 Shares of the Corporation over the Toronto Stock Exchange, resulting in Mr. Sprott’s beneficial ownership of the Corporation to decrease by approximately 2.5% since the date of the last early warning report.

The 19,200,200 Shares sold resulted in a decrease in holdings of approximately 2.5% of the Shares of the Shares outstanding from what was previously reported in the most recent early warning report. See items 2.2 and 3.4.

Mr. Spratt disposed of beneficial ownership of the Shares. See item 2.2.

Prior to the disposition, Mr. Spratt beneficially owned 121,843,998 Shares representing approximately 15.2% of the outstanding Shares on a non-diluted basis.

Mr. Spratt now beneficially owns 102,643,798 Shares representing approximately 12.8% of the outstanding Shares on a non-diluted basis.

Mr. Sprott currently has no other plans or intentions that relate to, or would result in, the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
