On July 29, 2020, 2176423 Ontario sold (the “**Disposition**”) ownership of 200,000 Shares over the Toronto Stock Exchange. 2176423 Ontario is beneficially owned by Eric Sprott. The sale resulted in a partially diluted beneficial ownership change of approximately 2.1% since the filing of the last early warning report.

The 200,000 Shares represent approximately 0.3% of the outstanding Shares on a non-diluted basis, and the Disposition results in a decrease in holdings of approximately 2.1% of the outstanding Shares on a partially diluted basis from what was reported in the last early warning report. Prior to the Disposition, Mr. Sprott beneficially owned and controlled 5,782,299 Shares and 6,832,319 Share purchase warrants representing approximately 9.4% on a non-diluted basis and approximately 18.4% on a partially diluted basis assuming exercise of such warrants.

After giving effect to the Disposition, Mr. Sprott now beneficially owns and controls 5,582,299 Shares and 6,832,319 Share purchase warrants representing approximately 9% on a non-diluted basis and 18.1% on a partially diluted basis assuming exercise of such warrants.

Mr. Sprott currently has no other plans or intentions that relate to, or would result in the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
