**NOTES:**

- (1) **A unitholder has the right to appoint a person to represent the unitholder at the Meeting other than the management representatives named in this proxy. This right may be exercised by inserting in the space provided the name of the other person the unitholder wishes to appoint. This other person need not be a unitholder in the Fund.**
- (2) To be valid, this proxy must be signed and deposited with **Data Processing Centre, P.O. Box 3700, STN Industrial Park, Markham, Ontario L3R 9Z9** so as to arrive at least 24 hours (excluding Saturdays, Sundays and public holidays) before the start of the Meeting or any adjourned, postponed or continued Meeting.
- (3) If the unitholder is an individual, this proxy must be executed exactly as the units are registered. For an individual unitholder who is voting on his or her own behalf, the unitholder has the option of voting by phone or by internet, in addition to the option of sending a signed proxy to Broadridge Investor Communication Solutions by mail, as described above. Please see the bottom for instructions to vote by phone or by internet. If a unitholder votes by phone or internet, the voting instructions received by Broadridge Investor Communication Solutions over the phone or the internet, as the case may be, will be deemed to be a valid proxy, and the unitholder voting by phone or by internet acknowledges, agrees and represents that any applicable written or execution requirement related to proxy voting has been satisfied.
- (4) If the unitholder is a corporation, an authorized officer or attorney must execute this proxy. Evidence of authority may be required. If units are registered in the name of an executor, administrator or trustee, this proxy must be executed exactly as the units are registered. If the units are registered in the name of a deceased or other unitholder, the unitholder's name must be printed in the space provided, the legal representative must sign this proxy with his or her name printed beside his or her signature and evidence of authority to sign on behalf of the unitholder must be attached to this proxy.

If no instruction has been given with respect to voting for or against the matters described above in this proxy, the management representatives will vote the units represented by this proxy FOR such matters. A unitholder or their proxy may only vote if the unitholder holds units of the Fund.**
