At the Meeting, securityholders of the Fund will be asked to consider and, if advisable, approve a change to the investment objectives of the Fund (the “**Objectives Change**”) as well as any other business that may properly be raised at the Meeting or any adjournment or continuation. A complete description of the matters to be considered in respect of the Objectives Change is set out in the section entitled “Proposed Change in Investment Objectives” in a management information circular dated December 20, 2024 (the “**Circular**”).
