Series F Securities are also available to other groups of investors for whom the Manager does not pay commissions.

Series I Securities are special-purpose Securities available only to other Invesco Canada Funds or eligible institutional investors or other permitted investors; they are not sold to the general public. Each Series I investor negotiates its own management and advisory fee that is paid directly to the Manager. Series I Securities are not generally sold through dealers, and no sales commissions are payable to dealers for selling these Securities.

Investment objectives and strategies

Prior to January 31, 2025, Invesco Managed Futures Fund (the "Fund") sought to provide total return with a low to moderate correlation to traditional financial market indices by investing, directly or indirectly, in a diversified portfolio of equity securities, fixed income securities and commodities located anywhere in the world. The Fund will strive to achieve this objective with a proprietary risk premium capture strategy that seeks to generate returns and minimize the risk of losses with a risk-balanced investment process. To reduce the impact of exchange-rate fluctuations, ordinarily derivatives are used, such that 80% or more of the Fund's foreign currency exposure is hedged.

Effective January 31, 2025, the investment objective and strategies of the Fund was changed. The Fund was also renamed from Invesco Balanced-Risk Allocation Pool to Invesco Managed Futures Fund. For more detailed information, please refer to the Fund's Simplified Prospectus.

Risk

Effective January 31, 2025, the risk rating of the Fund was changed from "Low to medium" to "Medium". This change was the result of the investment objectives and strategies change.

Results of operations

Performance

- Over the 12-month period, ending December 31, 2024, the Fund's Series I¹ returned 6.68%, outperforming its cash benchmark, the FTSE Canada 91-Day Treasury Bill Index, which returned 4.92% over the same period
- The Fund's return is after the deduction of fees and expenses, while benchmark returns do not include any costs of investing

Key drivers of performance

- The Fund's strategic exposure to equities was the primary contributor to absolute performance over the period, with all six equity markets in which the Fund invests delivering positive returns. Japanese equities led results for the asset class, benefitting from a weakened yen versus major trading partners
- The Fund's strategic exposure to commodities also contributed to absolute performance over the period, with gains in three out of the four sub-complexes. Precious metals, energy and industrial metals all delivered gains over the period while the agriculture complex declined in aggregate
- The Fund's strategic exposure to government bonds detracted from the Fund's absolute performance over the period, with negative results from five out of the six bond markets in which the Fund invests. U.K. gilts were the largest detractor amongst the government bond exposures
- Monthly tactical positioning contributed to results during the period, with positioning in both equities and commodities aiding results

Portfolio activity

- On a monthly basis, the team will rebalance and tactically shift assets to take advantage of near-term market opportunities. The tactical allocation process allows the asset weights to deviate from the strict risk-balanced strategic allocation structure. The allocations on December 31, 2024 are displayed below

Leverage

- Leverage occurs when a fund makes investments in derivatives for non-hedging purposes, borrows cash for investment purposes, or sells short equity securities, fixed income securities or other portfolio assets
- The Fund's aggregate exposure, calculated as the sum of the following, is not expected to exceed 250% the Fund's net asset value: (i) the aggregate value of outstanding indebtedness under any borrowing agreements; (ii) the aggregate market value of all securities sold short; and (iii) the aggregate notional value of the Fund's specified derivatives positions excluding any specified derivatives used for hedging purposes
- For the period ended December 31, 2024, Fund's lowest and highest aggregate exposure was 105.83% and 166.14% of the Fund's net asset value, respectively. The low end and high end of the range is due to the team's monthly strategic and tactical asset allocation process. The primary source of leverage is long positions in future contracts

Income, fees and expenses

- At the Fund level, significant components of income may include dividends, interest, realized and unrealized gains and losses. Significant components of expenses are primarily comprised of management fees and operating expenses. Amongst other factors, the value of these components may fluctuate as a result of changes to various drivers of income, fees and expenses such as average NAV, investment activity, account activity, and varying market conditions
- The management expense ratio (MER) decreased from 0.08% to 0.07% for Series I Securityholders. Please refer to the Financial highlights section for the MER of each series

Securityholder activity

- For the 12-month period ended December 31, 2024, the Fund's NAV decreased 61.19% to \$3.574 million from \$9.208 million. Of this change, an increase of \$590 thousand was attributed to operations and a decrease of \$6.224 million to net outflows

Recent developments as at January 10, 2025

Markets were choppy during the fourth quarter, with the U.S. election and central bank caution being the key drivers. Resilient economic growth combined with mixed inflation data caused an early quarter spike in volatility. Markets rebounded following the U.S. election but the optimism was short-lived as uncertainty around the new administration's policies, sticky inflation, and diverging economic outlooks set in. Global equity performance diverged and government bond yields rose as the U.S. dollar continued to surge and as central banks signaled a more gradual approach to monetary easing.

2024 was a year of economic resilience, which has carried over into 2025. The central question remains whether central banks can steer the world's major economies toward moderate growth while keeping inflation in check. Economic indicators suggest continued growth, with key market drivers from 2024 still in effect, setting the stage for "more of the same." However, several challenges are lurking. Persistent inflation, high U.S. equity valuations, rising bond yields, tight credit spreads, and a new U.S. presidential administration all have the potential to create volatility. These

factors could also lead to a broadening of what has been a narrow market, prompting investors to consider whether the sustainability of current economic resilience and U.S. and mega-tech dominance.

At the time of writing, it was anticipated that the incoming Trump administration in the U.S. would consider enacting tariffs on major trading partners including Canada, Mexico, and China. These protectionist policies, if implemented, could have a significant impact on the Canadian economy which relies heavily on exports to the U.S. Globally, such sweeping changes to global trade could create market turmoil as supply chains adjust, and risks putting inflationary pressure on the economy.

On December 16, 2024, Invesco Canada Ltd. announced that after more than two decades of dedicated service, senior portfolio managers Mark Ahnrud and Christian Ulrich are retiring. Mark will be retiring June 30, 2025, and Christian will be retiring March 1, 2026. As a result of these upcoming retirements, Invesco has updated the portfolio management team on the Fund accordingly. The following senior portfolio managers remain on the Fund: John Burrello, Chris Devine, Scott Hixon and Scott Wolle.

Effective September 30, 2024, Louise Brindle was appointed to the Fund's Independent Review Committee (IRC).

Subsequent to the as at date of the recent developments discussion, the Securityholders of the Fund approved changes to the Fund's investment objectives. As a result, effective January 31, 2025, the Fund's name was changed to "Invesco Managed Futures Fund", the investment strategies were updated to align with the new investment objectives, the risk rating of the Fund was changed from "Low-to-medium" to "Medium" and the Series F management and advisory fee was reduced from 1.00% to 0.85%.

The Fund's new investment objectives will be to seek to deliver a positive absolute return over a full market cycle with a low correlation to traditional financial market indices. The Fund invests primarily in long and short positions in a diversified portfolio of futures contracts, forward contracts and other derivatives that provide exposure to equity securities, fixed income securities, commodities and currencies located anywhere in the world. The Fund will use leverage through the use of derivatives, short selling or borrowing.

As a result of the investment objectives and strategies change, the Fund's benchmark will change to Société Generale Trend (SG Trend) Index.

Related party transactions

The Manager is responsible for the day-to-day operations of the Fund and provides management services to the Fund, including the marketing, promotion and distribution of the Fund; transfer agency services; and Securityholder reporting and servicing. The Fund receives investment advisory services provided by the Manager or affiliates of the Manager. These services are in the normal course of operations and are recorded at the amount of the consideration agreed to by the parties. The Fund is sub-advised by Invesco Advisers, Inc., an affiliate of the Manager.

Each Fund pays a management and advisory fee to the Manager, based on an annual rate and the Net Asset Value of each series of the Fund. Where applicable, the management and advisory fee includes any sub-advisory fee that the Manager pays directly to a sub-advisor. The management and advisory fees for Series I are

negotiated and paid directly by Series I Securityholders, and not the Fund. The Manager may agree to reduce the normal management and advisory fee it charges a Fund in respect of large Securityholders of a Fund based on agreements between the Manager and the Securityholders.

The Manager incurs operating expenses on behalf of the Fund and is then reimbursed by the Fund for such expenses.

To assist in the discharge of its duties with respect to the Fund, the Manager has appointed the Invesco Canada Funds Advisory Board (the "Advisory Board"). The majority of Advisory Board members are independent of the Manager. The Advisory Board reviews the investment performance, investment policies, financial statements, trading policies and other similar matters related to the operations of the Fund, and reports its findings, makes recommendations and gives approvals, as appropriate, to the Manager with respect thereto. In addition, the Manager has appointed the IRC established under the Canadian Securities Administrators' National Instrument 81-107 *Independent Review Committee for Investment Funds*. The members of the IRC are the current independent members of the Advisory Board. The mandate of the IRC is to review, and provide input on, the Manager's written policies and procedures that deal with conflict-of-interest matters in respect of the Funds. The IRC may also approve certain mergers involving the Funds and any change in the auditor of the Funds. Additional information about the IRC is available in the Invesco Simplified Prospectus. Independent members of the Advisory Board and members of the IRC receive fees for services rendered to the Funds.

In the case of certain Funds, the Manager provided start-up investment capital. The Manager's investment in the Funds is recorded at the Net Asset Value per Security of each series, as applicable.

Certain of the Funds participated in portfolio transactions with other Funds managed or sub-advised by the Manager. These transactions were executed through market intermediaries and under prevailing market terms and conditions.

^{***} On November 4, 2022, the Fund became a reporting issuer under National Instrument 81-102 *Investment Funds*. Prior to this date, the Fund was offered by way of private placement. The Manager obtained exemptive relief to include in its annual and interim management reports of fund performance (MRFP) the past financial highlights notwithstanding that such financial highlights relate to a time period prior to the Fund offering its Units under a simplified prospectus.

⁽¹⁾ This information is derived from the Fund's audited annual financial statements. For purposes of Securityholder purchases, switches and redemptions, the Net Asset Value is calculated in accordance with the valuation rules as set out in the Fund's Invesco Simplified Prospectus.

⁽²⁾ Net Asset Value per Security and distributions are based on the actual number of Securities outstanding at the relevant time. The increase/(decrease) from operations is calculated based on the average number of Securities outstanding over the period. Therefore, the beginning of period Net Asset Value per Security, the increase/(decrease) from operations and distributions, if any, will not sum to the end of period Net Asset Value per Security.

⁽³⁾ Distributions were paid in cash/reinvested in additional Securities of the Fund, or both. For each series, distributions to Securityholders are calculated based on the number of Securities outstanding on the record date for each distribution of that series.

⁽⁴⁾ For each series, the management expense ratio is calculated based on the total expenses of that series of the Fund (including Goods and Services Tax, Harmonized Sales Tax and interest, but excluding brokerage commissions and other portfolio transaction costs), and is expressed as an annualized percentage of daily average Net Asset Value of that series of the Fund during the period.

Prior to becoming a reporting issuer on November 4, 2022, at its sole discretion, the Manager had absorbed some operating expenses for Series F. The Management expense ratio and Management expense ratio including fees/ expense waived/ absorbed by Manager would have been higher had the Fund been subject to the current operating expense limits and expenses associated with additional regulatory requirements applicable to reporting issuers for the entirety of each reporting period disclosed.

Series I expenses, prior to the Fund becoming a reporting issuer on November 4, 2022, would have been higher had the Fund been subject to the expenses associated with additional regulatory requirements applicable to a reporting issuer for the entirety of each reporting period disclosed. At all times, the Management expense ratio of Series I (excluding HST) is and has been capped at 0.10%.

⁽⁵⁾ The Fund's portfolio turnover rate indicates how actively the Fund's portfolio manager/management team manages its portfolio investments and it relates to the portfolio investments of the Fund as a whole. A portfolio turnover rate of 100% is equivalent to the Fund buying and selling all of its portfolio investments once in the course of the period. In general, the higher a fund's portfolio turnover rate in a period, the greater the trading costs payable by the fund in the period, and the greater the chance of an investor receiving taxable capital gains in the period. There is not necessarily a relationship between a high turnover rate and the performance of a fund. The portfolio turnover rate is calculated based on the lesser of purchases or sales for the period, excluding money market funds, futures contracts and portfolio investments having maturity dates at acquisition of one year or less, divided by the average market value (at last traded market prices) of the portfolio of investments for the period. Where the reporting period is less than or greater than 12 months, the portfolio turnover rate has not been annualized and will not be comparable to the portfolio turnover rate calculated for reported 12-month periods.

⁽⁶⁾ The trading expense ratio (TER) represents total commissions and other portfolio transaction costs expressed as an annualized percentage of daily average Net Asset Value of the Fund during the period and it relates to the Fund as a whole.

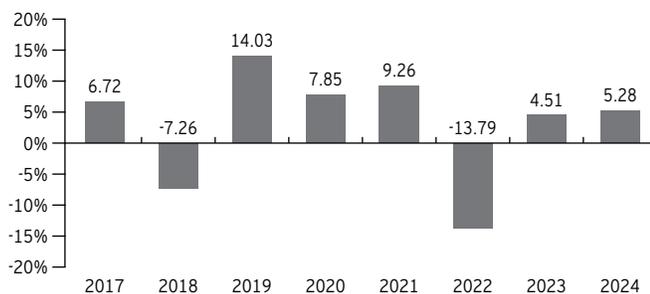
Past performance

The following charts show the Fund's past performance. The past performance information shown includes changes in security value; assumes the reinvestment of all distributions; and does not take into account sales, redemption, distribution or optional charges, or income taxes payable by any investor, which would have reduced returns. It is important to note that the past performance of the Fund does not tell you how the Fund will perform in the future. Commencing July 18, 2017 and November 16, 2012, respectively, (the "Private Start Dates"), Series F and I units of the Fund were sold via private placement. On November 4, 2022 (the "RI Date"), the Fund became a reporting issuer ("RI") by prospectus clearing its units. The Fund was not an RI from the Private Start Dates to the RI Date (the "Private Period"). As part of the prospectus qualification, the Fund changed its investment objectives and became subject to additional regulatory requirements applicable to an RI (the "RI Rules"). These changes did not affect the manner in which the Fund is managed. The Manager obtained relief on behalf of the Fund to allow disclosure of Fund performance data from the respective Private Start Dates. The Fund's expenses during the Private Period would have been higher had the Fund been subject to the RI Rules.

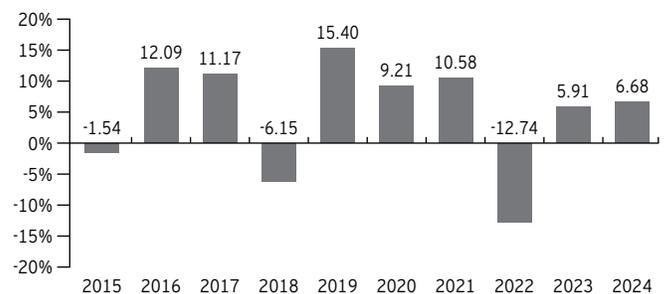
Period-by-period returns

Benchmarks

The **FTSE Canada 91-Day Treasury Bill Index** measures the return attributable to 91-day Treasury bills that are issued and secured by the Canadian government. The index consists of short-term T-bills which are money market instruments that are generally considered to be cash equivalents and risk-free. The Fund has significant exposure to equities, fixed income and commodities through derivatives and is not a risk-free investment.

The Fund uses the **60% MSCI World Index (local currency)/40% Bloomberg Global Aggregate Bond Index (CAD Hedged)** for risk assessment purposes. This blended index is made up of a 60% weighting in the MSCI World Index (local currency) and a 40% weighting in the Bloomberg Global Aggregate Bond Index (CAD Hedged).

While the Fund uses these indices for long-term performance comparisons and risk assessment purposes, it is not managed relative to the composition of the indices. As a result, the Fund may experience periods when its performance differs from these indices. Please see the *Results of operations* section of this report for a discussion of recent performance results.
