The simplified prospectus dated July 30, 2025 as amended by Amendment No. 1 dated August 20, 2025 (the “**Prospectus**”), relating to the offering of mutual fund shares and units of the Funds, is hereby amended as set out below. All capitalized words have the respective meanings set out in the Prospectus, unless specifically defined in this Amendment No. 2.

PROPOSED ACQUISITION OF THE ASSETS OF INVESCO CANADA LTD.

On January 13, 2026, Invesco Canada Ltd. (the “**Manager**”) announced that it has entered into a definitive agreement to sell the management agreements relating to its Canadian fund business to CI Investments Inc., operating as CI Global Asset Management (“**CI GAM**”). Under the terms of the agreement and subject to the receipt of all necessary consents and approvals, CI GAM will become the investment fund manager, portfolio manager and trustee, as applicable, of the Funds and CI GAM will enter into a long-term arrangement with certain Invesco affiliates to continue to provide sub-advisory services in respect of certain Funds (the “**Transaction**”).

The Transaction will result in CI GAM becoming the investment fund manager, portfolio manager and trustee, as applicable, of the Funds following closing of the Transaction, while Invesco affiliates will continue to act as sub-advisers for the Funds listed below:

The Transaction is subject to receipt of applicable regulatory approvals as well as satisfaction of other customary closing conditions. The change in manager of the Funds is subject to approval by the securityholders of the Funds (collectively, “**Securityholders**”). The Manager has called special meetings of Securityholders of the Funds to consider the change of manager, which are expected to be held on or about April 13, 2026. An information circular describing the change of manager will be mailed to Securityholders in advance of the special meetings. Should any Fund not obtain the requisite Securityholder approval, the Fund will be terminated. Assuming satisfaction of all approvals and conditions, the Transaction is expected to close by the end of the second quarter of 2026.

PURCHASERS’ STATUTORY RIGHTS

Securities legislation in some provinces and territories gives you the right to withdraw from an agreement to buy mutual funds within two business days after you receive the simplified prospectus or Fund Facts, or to cancel your purchase within 48 hours after you receive confirmation of your order.

Securities legislation in some provinces and territories also allows you to cancel an agreement to buy mutual fund shares or units and get your money back, or to make a claim for damages, if the simplified prospectus, Fund Facts or financial statements misrepresent any facts about the Fund.

You must usually exercise these rights within a certain time period. You can get more information from the securities legislation of your province or territory or from your lawyer.
