On August 17, 2017 Burgundy acquired shares of the Reporting Issuer.

Since December 31, 2016 (the date of Burgundy's last report), Burgundy's holding of common shares of the Reporting Issuer has increased by 5,037,684 shares. The shares outstanding have increased by 2,742,000 shares since the previous report. This has caused Burgundy's holdings to increase by 2.8999% of the outstanding shares since the last report filed by Burgundy.

22,991,239 shares of the Reporting Issuer, representing 14.0930% of the outstanding shares of the Reporting Issuer.
