Since August 31, 2017 (the date of Burgundy's last report), Burgundy's holding of common shares of the Reporting Issuer has decreased by 2,978,996 shares. The shares outstanding have decreased by 2,648,000 shares since the previous report. This has caused Burgundy's holdings to decrease by 1.6237% of the outstanding shares since the last report filed by Burgundy.

20,012,243 shares of the Reporting Issuer, representing 12.4694% of the outstanding shares of the Reporting Issuer.
