On December 9 2025, Sprott Mining Inc., a subsidiary of 2176423 Ontario Ltd., a corporation beneficially owned by Eric Sprott, sold a total of 5,000,000 Shares of the Corporation at a price of approximately \$6.7910 per Share over the Toronto Stock Exchange, resulting in Mr. Sprott’s beneficial ownership of the Corporation to decrease by approximately 3.3% since the date of the last early warning report.

The 5,000,000 Shares sold resulted in a decrease in holdings of approximately 3.3% of the outstanding Shares from what was previously reported in the most recent early warning report. See items 2.2 and 3.4.

Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
