On November 20, 2025, 2176423 Ontario, a corporation beneficially owned by Eric Sprott, purchased a total of 250,000 Shares of the Corporation at a price of approximately \$5.41 per Share over the Toronto Stock Exchange, resulting in Mr. Sprott’s beneficial ownership of the Corporation to decrease by approximately 2.3% since the date of the last early warning report.

The 250,000 Shares acquired resulted in a decrease in holdings of approximately 2.3% of the Shares outstanding from what was previously reported in the most recent early warning report. See items 2.2 and 3.4.

Mr. Spratt acquired beneficial ownership of the Shares. See item 2.2.

Prior to the acquisition of Shares, Mr. Spratt beneficially owned 48,903,940 Shares representing approximately 17.9% of the outstanding Shares.

Mr. Spratt now beneficially owns 49,153,940 Shares representing approximately 18.0% of the outstanding Shares.

Mr. Sprott has a long-term view of the investment and may acquire additional securities including on the open market or through private acquisitions or sell securities including on the open market or through private dispositions in the future depending on market conditions, reformulation of plans and/or other relevant factors. Mr. Sprott currently has no other plans or intentions that relate to, or would result in, the matters listed in clauses (a) to (k), above. Depending on market conditions, general economic and industry conditions, the Corporation's business and financial condition and/or other relevant factors, Mr. Sprott may develop such plans or intentions in the future.
