As a result of net purchases of common shares of the Issuer (“**Common Shares**”) in August 2021 by Crescat, an investment manager with discretionary authority operating in the United States, the collective holdings of Crescat and the Joint Actors (as defined herein) in the Issuer have risen above 10%.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

As at August 31, 2021, Crescat exercised control over 6,826,975 Common Shares, representing approximately 7.38% of the outstanding Common Shares, and 3,095,236 common share purchase warrants of the Issuer (“**Warrants**”). Assuming that the Warrants are exercised, Crescat will hold 9,922,211 Common Shares representing approximately 10.38% of the issued Common Shares on a partially diluted basis as at August 31, 2021.

Assuming the Warrants are exercised, Crescat and the Joint Actors will collectively exercise control over an aggregate of 9,962,211 Common Shares representing approximately 10.43% of the outstanding Common Shares on a partially diluted basis as at August 31, 2021.
