##### **2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.**

The requirement to file this report was triggered by the closing of the Private Placement on August 2, 2022, in which Crescat acquired 2,342,293 units of the Issuer (the “**Units**”) at a price of \$1.25 per Unit. Each Unit was comprised of one common share of the Issuer (each, a “**Common Share**”) and one-half of one Common Share purchase warrant of the Issuer (each whole Common Share purchase warrant, a “**Warrant**”). Each Warrant entitles the holder thereof to acquire one Common Share at a price of \$2.50 per Common Share for a term of two years.

##### **2.3 State the name of any joint actors.**

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

Crescat is eligible to file reports under Part 4 in respect of the Issuer.

There has been a net increase of 7,337,991 Common Shares and 1,171,146 Warrants in Crescat's holdings representing an increase of approximately 2.73% on a non-diluted basis and, assuming that all of the Warrants held by Crescat are exercised, an increase of approximately 2.64% on a partially diluted basis.

**3.2 State the designation and number or principal amount of securities and the eligible institutional investor's securityholding percentage in the class of securities at the end of the month for which the report is made.**

As at August 31, 2022, Crescat exercised control over 22,458,639 Common Shares, representing approximately 17.24% of the outstanding Common Shares, and 5,681,477 Warrants. Assuming that all of the Warrants held by Crescat are exercised, Crescat will hold 28,140,116 Common Shares representing approximately 20.70% of the issued Common Shares on a partially diluted basis as at August 31, 2022.

As at August 31, 2022, Crescat and the Joint Actors collectively exercised ownership and control over a total of 23,704,379 Common Shares (representing approximately 18.20% of the outstanding Common Shares) and 5,728,647 Warrants. Assuming that all of the Warrants held by Crescat and the Joint Actors are exercised, Crescat and the Joint Actors will collectively exercise ownership and control over an aggregate of 29,433,026 Common Shares representing approximately 21.64% of the

outstanding Common Shares on a partially diluted basis as at August 31, 2022.
