This report was triggered by an increase in the Issuer’s issued and outstanding share capital, the net sale of common shares of the Issuer (“**Common Shares**”) that occurred over the TSX Venture Exchange and by the expiration of share purchase warrants of the Issuer (“**Warrants**”) held by the eligible institutional investor.

As a result of net sales of Common Shares by Crescat in July 2023, the expiration of Warrants and an increase in the Issuer’s issued and outstanding share capital, the collective partially diluted holdings in the Issuer of Crescat and the Joint Actors (as defined herein) have fallen below 10%.

2.3 State the name of any joint actors.

Kevin Smith, Kevin Smith 401K Plan, Linda Smith, and Kevin and Linda Smith Living Trust dtd 7/21/1998 (the “**Joint Actors**”) may be considered joint actors.

There has been a net decrease of 972,624 Common Shares and 1,428,572 Warrants in Crescat's holdings representing a decrease of approximately 0.78% on a non-diluted basis and, assuming that all of the remaining Warrants held by Crescat are exercised, a decrease of approximately 1.69% on a partially diluted basis.

As at July 31, 2023, Crescat exercised control over 9,307,764 Common Shares, representing approximately 6.56% of the outstanding Common Shares, and 2,586,240 Warrants. Assuming that all of the Warrants held by Crescat are exercised, Crescat will hold 11,894,004 Common Shares representing approximately 8.23% of the issued Common Shares on a partially diluted basis as at July 31, 2023.

As at July 31, 2023, Crescat and the Joint Actors collectively exercised ownership and control over a total of 10,469,164 Common Shares (representing approximately 7.37% of the outstanding Common Shares) and 2,633,410 Warrants. Assuming that all of the Warrants held by Crescat and the Joint Actors are exercised, Crescat and the Joint Actors will collectively exercise ownership and control over an aggregate of 13,102,574 Common Shares representing approximately 9.06% of the

outstanding Common Shares on a partially diluted basis as at July 31, 2023.
