2. **TO ELECT** the directors of the Company;
3. **TO RE-APPOINT** the auditors of the Company and to authorize the board of directors to fix the auditors’ remuneration;
4. **TO CONSIDER** an advisory (non-binding) resolution on executive compensation;
5. **TO TRANSACT** such further and other business as may properly come before the Meeting or any adjournment or adjournments thereof.
