On November 23, 2023, the Corporation sold (the “**Disposition**”) all of the 21,280,000 Common Shares held by the Corporation.

Ocean Infinity held a small minority ownership position in Kraken that became non-core as its business expanded to include surface robotics. The Disposition was made to redeploy funds away from its Kraken position at a good profit after 5 years of ownership. The Corporation may, from time to time, take such actions in respect of securities of the Issuer, as it may deem appropriate, in light of the circumstances then existing, including the purchase of Common Shares or other securities of the Issuer, subject to applicable securities laws and the terms of such securities.
