Pelicourt Ltd. (“**Pelicourt**”) is the largest Shareholder of Cub Energy Inc. (“**Cub**” or “**Issuer**”), owning 124,336,089 common shares (39.5% of the issued and outstanding shares of Cub). On February 3, 2021, the Issuer announced the sudden passing of Mikhail Afendikov, the former Chairman, Chief Executive Officer and ultimate beneficial owner of a 72.4% equity interest in Pelicourt. Mr. Afendikov’s 72.4% ultimate beneficial interest has now been transferred to Lilia Afendikova. Mr. Afendikov was the spouse of Ms. Afendikova.

Pelicourt is incorporated under Cyprus Companies Law, having its registered office at 1, Costakis Pantelides Ave, 3rd floor, Kolokassides Building, 1010 Nicosia, Cyprus.
