The requirement to file this report was triggered by the disposition by BCPI of an aggregate of 360,000 Common Shares pursuant to transactions through the facilities of the New York Stock Exchange on November 30, 2020.

BCPI disposed of an aggregate of 360,000 Common Shares. Following such disposition BCPI owned 9,612,502 Common Shares representing approximately 9.99% of the issued and outstanding Common Shares.
