Agnico Eagle is a senior gold mining company organized under the laws of the Province of Ontario.

**2.2 State the date of the transaction or other occurrence that triggered the requirement to file this report and briefly describe the transaction or other occurrence.**

On the date hereof, concurrent with the closing of the Private Placement (as defined below), Agnico Eagle exercised its right under the Investor Rights Agreement (as defined below) to designate Carol Plummer to be appointed, or nominated for election, to the board of directors of Rupert (the “Nomination”).

On March 31, 2025, Agnico Eagle entered into a subscription agreement pursuant to which Agnico Eagle agreed to acquire, and Rupert agreed to issue, 2,602,500 Common Shares at \$4.50 per Common Share for total consideration of \$11,711,250 in a non-brokered private placement (the “Private Placement”). The Private Placement closed on April 1, 2025.

Prior to the Private Placement, Agnico Eagle owned 30,169,111 Common Shares, representing approximately 13.3% of the issued and outstanding Common Shares on a non-diluted basis. On closing of the Private Placement, Agnico Eagle owned 32,771,611 Common Shares, representing approximately 14.0% of the issued and outstanding Common Shares on a non-diluted basis.

Agnico Eagle acquired the Common Shares for investment purposes. Agnico Eagle may, from time to time, acquire additional Common Shares or other securities of Rupert or dispose of some or all of the Common Shares or other securities of Rupert that it owns at such time. Other than the Nomination, Agnico Eagle currently has no other plans or intentions that relate to or would result in any of the actions listed in items (a) to (k) above, but depending on market conditions, general economic and industry conditions, trading prices of Rupert's securities, Rupert's business, financial condition and prospects and/or other relevant factors, Agnico Eagle may develop such plans or intentions in the future. Rupert advised Agnico Eagle that its nominee will be nominated for election and included in Rupert's proxy circular for its upcoming annual general meeting.

Agnico Eagle and Rupert are parties to an investor rights agreement dated February 11, 2020 (the "Investor Rights Agreement"), pursuant to which Agnico Eagle is entitled to certain rights (subject to maintaining certain ownership thresholds), including: (a) the right to participate in equity financings in order to maintain its *pro rata* ownership in Rupert at the time of such financing or acquire up to a 16.1% ownership interest in Rupert; and (b) the right to nominate one person (and in the case of an increase in the size of the board of directors of Rupert to eight or more directors, two persons) to the board of directors of Rupert.
